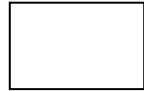


## Offer to rent a furnished room



### General

The terms include specific terms that apply to you, and general terms for all tenants.

A surety and/ or the other tenant in a double toom renting together with you also agree to all these terms as if they are you.

If we accept your offer, it becomes a binding lease agreement between you and us. A lease agreement is a contract that holds you responsible to pay rent. If we do not accept your offer to rent, there is no agreement.

**You must pay an administration fee of R300 on acceptance by us of your offer.**

#### 6. Rent (for double rooms, see NB below and Terms & Conditions cl. 5)

You must pay the total rent without any deductions before or by the **first day of each month**. Failure to do so is a breach of the lease contract.

The rent includes electricity, water, gas for cooking, furniture and other items or contents on the list attached.

**NB:** 2 tenants together renting a double room on the same lease form, do so **jointly and severally**. This means we can hold **each of you** or the surety or both responsible for the **total rent** of a double room, eg, if the other tenant moves out, is evicted, or stops paying rent. This does not apply if sharing tenants individually rent a shared room.

#### 7. Municipal and other charges to us (see cl 3 in the General Terms)

Included in your rent is a fair share of the cost of municipal and other charges for services provided: electricity, water, sewerage, refuse removal, gas, internet, etc.

#### 8. Increases to rent and to municipal charges

1) Rent increases on 1<sup>st</sup> January each year or from the month following expiry month of your lease, at a fair market escalation, and published on [www.junctionroad.co.za](http://www.junctionroad.co.za)
